The Frederick Arts & Humanities Council reserves the right to require the removal of unacceptable work. No refunds will be made for non-compliant exhibitors.

The deadline for entries is September 11, 2026. Only forty spaces are available – eight 4' X 8' panels on stands and thirty-two 10' X 10' open spaces. No refunds will be made after September 14, 2026.

All applications must include an entry fee and include three representative photographs for each category for which the artist is applying. Photographs must be labeled with the artist's name and the appropriate category.

The show is open to artists and craftspeople exhibiting their own original works.

Only original arts and crafts will be accepted. Works purchased by the exhibitor for resale will not be allowed.

The Frederick Arts & Humanities Council reserves the right to require the removal of unacceptable work. No refunds will be issued to non-compliant exhibitors.

**Deadline:** The application deadline is September 11, 2026. No refunds for cancellations received after September 14, 2026.

**Festival:** Saturday, September 19, 2026, 9:00 a.m. to 3:00 p.m. in Frederick at the Tillman County Courthouse Square, on the corner of Highway 183 and Highway 5. The check-in booth will be open at 7:30 a.m. at the South entrance of the Courthouse. No early releases.

Only 40 entries will be accepted – eight 4' X 8' panels on stands or thirty-two 10' X 10' open spaces. Artists will need metal drapery hooks to hang on our plastic mesh panels and must furnish their own tables, chairs, etc. The Chairman of the Festival reserves the right to limit entries in each category.

**Inclement Weather:** The Festival will be relocated to the Tillman County Fair Barn located at 700 S. 8th Street in Frederick, in the event of rain. Vendors will be informed of a venue change no later than Friday morning, September 19.

**Fee:** \$45.00 for a 10' X 10' open space or two 4' X 8' mesh panels.

**Hostesses:** Hostesses will be available to provide artists with short breaks.

**Entertainment:** Various entertainment and activities will be presented throughout the day.
